- acknowledges the contagious nature of COVID-19 and voluntarily assumes the risk that the Renter's agents, employees, invitees, contractors or participants may be exposed to or infected by COVID-19 as a result of attending Renter's activity/event within the Facility and that such exposure or infection may result in personal injury, illness, permanent disability and death;
- acknowledges the requirements and recommendations of provincial and local public health authorities and the special safety regulations put in place by the Town of Langham as it pertains to COVID-19 and accepts responsibility for encouraging compliance by the Renter's agents, employees, invitees, contractors or participants while visiting the Facility;
- agrees to indemnify and hold harmless the Town of Langham and the Town's elected officials, officers, directors, agents, employees, contractors, successors and assigns (collectively referred to as "Town") from and against any and all actions, claims, demands, suits, proceedings, damages, costs (including without restriction legal costs on a solicitor and his own client full indemnity basis) and expenses whatsoever that may be brought, made or incurred by or against the Town by reason of, arising out of, or in any way related to the Renter, its agents, employees, invitees, contractors or participants being exposed to COVID-19 while utilizing and/or visiting the Facility;
- agrees to immediately notify the Town should there be a subsequent positive COVID-19 test arising from the Renter's occupation of the Facility or any known case of COVID-19 of any participant, agent, employee, invitee or contractor of the Renter that was present at the Facility during the time of the Renter's activity or event within the Facility; and
- has read and understands the foregoing, has had the opportunity to ask questions and clarifications before signing and consents, approves and agrees to the above.
